**A RESOLUTION TO ADOPT RATES AND CHARGES
FOR THE CITY WASTEWATER SYSTEM**

Minutes of a Regular Meeting of the City Council of the City of Luna Pier, County of Monroe, Michigan (the “City”), held on the 12th day of September, 2019 at 7:00 p.m., Eastern Daylight Time.

Present: Councilmember’s Wakeman, Gramza, Anstadt, Grimes, Russell, Meadows, Mayor Gardner

Absent: None

The following preamble and Resolution were offered by Councilmember Wakeman and supported by Councilmember Grimes.

WHEREAS, the City of Luna Pier owns and operates a system for the collection and treatment of wastewater, and

WHEREAS the City determines that the cost of operating and maintaining the wastewater system should be fairly and equitably recovered from the customers who use the service, and

WHEREAS the City has adopted Ordinance Number 197 which requires fixed-rate charges based upon the size of customers’ water meters, and volume charges based upon the volume of water measured by the customers’ water meter;

NOW THEREFORE, BE IT RESOLVED that the following fixed-rate charges are approved:

BE IT FURTHER RESOLVED that the above rates will increase by 10% per year through 2024.

BE IT FURTHER RESOLVED that the City establishes a volume charge based on the amount of water measured by the water meter, and calculated at a rate of \$10.17 per 1,000 gallons.

BE IT FURTHER RESOLVED that any Resolution of part thereof in conflict herewith is rescinded.
