5. Old Business:

- A. Council Rep report: Jim Gardner
 - Parks and Recreation Committee is discussing the possibility of dredging the inside of the harbor to make it accessible for boats. It would be smarter and less duplication to let the FEP committee pursue the permit that can be used to do this.
- B. Vice Chair Report: Ric Murray
 - Mayor Dave is tossing around the idea of proposing that the residents that want their cylinders removed might be asked to pay \$200.00 per cylinder.

- C. Treasurers Report: Robin Walton
 - In account 100, we have \$31,148.95. There was a bill paid to Professional Pump, Inc for \$133.72 that should have been expensed to the Treatment Plant. The adjustment will be made, making the total in this account \$31,282.67
 - In account 105, we have \$46,490.66. We had 3 bills paid to Frontier: \$33.36, \$54.81, and \$55.22. We had 2 bills paid to Consumers Energy for \$110.50 and \$139.39.
 - The current balance in the CD was reported as \$205,884.66. We feel this is a mistake and Robin will contact Crystal to find out. The balance in the FEP account is \$283,657.99

 - Ric and Stacy met with Charles Londo about the After the Fact Permit. More sketches need to be drawn up showing cross-sections of cylinders and describing what the cylinders were filled with.
 - Stacy received a letter from the DEQ. Apparently the Army Corp of Engineers contacted them about the what work we did and they would also like sketches and a copy of the After the Fact Permit when we get it.
 - Lake level is 1" higher than it was last year.
