- A. Council Rep report: Jim Gardner
 - Discussed the email forwarded by Mayor Davidson about FEMA's Risk MAP Flood Risk Products.

- C. Treasurers Report: Robin Walton
 - In January the balance in the CD was reported as \$205,884.66. I checked with Crystal and that was incorrect. Dee said the balance in the CD as of Dec. 31 was \$222,513.70. This corrects the balance for the January meeting to \$300,153.31.
 - In account 100, we have \$31,287.40
 - In account 105, we have \$46,553.22. We had a January bill from Consumers Energy of \$170.64, a February bill from

- Consumers Energy of \$155.00, and a bill from Frontier of \$55.31.

 - Residents in Allen Cove that had sills removed were contacted by the Army Corps of Engineers regarding the After the Fact Permit. Stacy talked to Rachel from the Corp of Engineers and she said there were no complaints filed. We are not sure what happens next. Will we need another permit to do any more work?
 - As soon as the weather breaks more measurements will need to taken on the leaning wall in Allen Cove. We are hopeful that the sills being placed up against the wall will support it and decrease the chance that it will lean any more.
