**The City of Luna Pier**, prior to its incorporation as a city in 1963, was a small resort community that began developing during the early 1900's. This was mainly due to its access to Lake Erie and location near Toledo. The 2000 Census reports that population at 1483 and the land area of the city is 1,075 acres. The community has 4½ miles of continuous shoreline with a city pier, public beach, public and private marinas, boat launching facilities, a canal system and four recreational parks.
