#### Mayor's Report Spring Newsletter 2022

Springtime in Luna Pier is always an exciting time and after all that we have been through the last two years, this spring is especially refreshing. It's a great time to get out and enjoy the natural resources that make Luna Pier such a great place to live. I look forward to seeing everyone out in the community and at city functions that we have missed out on the past couple of years. As always, we have some challenges ahead navigating this changing world but I believe we have the right leaders in elected and appointed positions and in our community in general to build a bright future here.

Road funding continues to be a challenge as our streets show their age. Michigan ranks among the lowest states in the country



in road funding per lane mile which comes at no surprise seeing the condition of our state and local roads. In Luna Pier it is even more challenging as many of our streets were paved at about the same time and are all reaching the end of their designed life cycle. When Lakewood Road and Luna Pier Road reached a state that posed an immediate safety risk due to the condition of the streets and sidewalks, we were only able to correct the problems through low interest loans that we are now paying back with current road funds. It was the right decision to protect public safety but limits our ability to address all of the needs we see and would love to correct now. A safe walkable community is a top priority for me and is vital to any vibrant community. I wish we could do more. There is some light ahead as road funding has been slightly increasing and we will continue to do the most with what we have. We hear you and will keep exploring every option to improve our streets. The next phase of the I-75 repaving project has started with limited prep work scheduled for 2022. The project ramps up significantly in 2023 with the demolition of the northbound lanes from Erie Road to S. Otter Creek. Two-way traffic will be maintained on the current Southbound Road through 2023. Some work will be done to the Gaynier Rd bridge deck which will result in two-way traffic reduced to one lane with a temporary signal at some point. All work there is scheduled to be competed in 2023.

2024 kicks off the bulk of the project with the southbound lanes being demolished and repaved along with the replacement of all ramps at Luna Pier Road and the replacement of the overpass. All exit and entrance ramps will remain open at Luna Pier Road throughout the project including the demolition and replacement of the overpass. Southbound I-75 traffic from Luna Pier will be routed north on I-75 to exit and re-enter southbound I-75 at S. Otter Creek Rd. Southbound I-75 traffic entering Luna Pier will be directed to the Erie Rd. exit for re-entry northbound to exit 6. At no time will I-75 traffic be routed through Luna Pier. No round-abouts are planned for exit 6.

The new overpass will be significantly wider and over two feet higher. In addition to the two travel lanes, there will be a 10-foot shoulder on the south side and a dedicated pedestrian and bicycle lane on the north side separated from vehicle traffic by a barrier. It is a huge improvement over the original bridge still standing since 1955 when I-75 was constructed. MDOT is funding the project, including the non-motorized lane with barrier and fence to protect cyclists and pedestrians. The construction project will present challenges and will be quite inconvenient at times but when it is complete, it will be well worth the wait.

It's great to get out and enjoy the spring and summer in a great community of neighbors who care.

# **CITY GRANT ACTIVITY UPDATE:**

Grant activity during Fall-2021 to Spring-2022 is as follows:



#### NEW AWARDS:

 DENNIS LEARY FIREFIGHTER FOUNDATION – the LPVFD was awarded \$47,693 for the purchase of a new Ford F150 Rescue Vehicle. This exciting acquisition will be outfitted with safety/security equipment and cabinetry for the storage of life-saving tools. Thanks to Terry Mueller and Derrick Welton for their contributions. The vehicle should be in the LPVFD fleet by March 1, 2022.

#### FAILED ATTEMPTS:

- Our attempt to get the LPPD two speed signs for Harold Drive unfortunately was denied.
- Our attempt to acquire two Evidence Lockers and a Gun Cabinet for the LPPD was denied.

IN-PROGRESS (AWARDED) GRANTS:

 FEMA/SAFER grant – Project Manager – Jim Gardner, \$89,020 – This grant is to give the present Volunteer Fire Department membership a larger stipend per call and incentives for service and merit awards. It also is funding the recruitment of 8 new members over the next 2-3 years which includes their training, equipment costs, as well as a long-term recruitment process to be created. We have received \$11,600 of the award so far.

### CLOSED DURING PERIOD:

- FEMA/COVID grant Project Manager Derrick Welton, \$5126 – This grant was for Vinyl Gloves, Electrostatic Sprayer and Solution, a hand washing and hand sterilization station for the LPVFD; however, these COVID PPE products can be used throughout the city. We have received \$4,775 of the award and it will be closed.
- FEMA/AFG grant Project Manager Derrick Welton, \$66,426 – This newly approved grant includes three chain saws of varying capability, a Mobile Air Filling Station for our larger Rescue Vehicle, and a JAWS OF LIFE Cutter / Spreader for the LPVFD. We received \$66,375 of the award and it will be closed.
- We decided against submitting a Joint VFD / REGIONAL grant request as mentioned in our last report. There was limited interest which made the large effort unlikely to succeed. We have our eyes on other REGIONAL grant opportunities in the future however.

#### GRANTS WAITING APPROVAL:

- We submitted a 2021 FEMA AFG grant application for the acquisition of 16 Air Tanks for the ERIE VFD. Since we had success with this grant for ourselves (LPVFD) in 2020, we were asked to replicate the experience. We were happy to do so. The request was for \$137,232
- We submitted a 2021 FEMA AFG grant application for the acquisition of two Battery operated Ventilation Fans for the LPVFD. The request was for \$10,400.
- We played a minor role in assisting the Lotus Manor Apartments in the development of a grant to acquire a Security Camera system. We were very happy to of played a small role.
- GRANTS IN THE DEVELOPMENT PROCESS:
  - A meeting with newly installed Police Chief, John Poe, took place where he outlined some of his hopes for grant projects in 2022. A list was formulated and submitted for review and approval by the Luna Pier Police Advisory Council and City Council, where appropriate.
  - Discussion is still underway to provide help to the Parks & Recreation Committee to acquire funds to accomplish some of their 2022 priorities.
  - Other grants are being considered as opportunities arise.

#### OTHER NEWS:

- The GRANT MANAGEMENT team is in need of help to plan, develop, maintain, and close these important efforts. The good news is that Megan Niner, a resident of Luna Pier, and a very qualified administrator, has offered to help, as has, Chris Burchett, the energetic chairperson of the Parks and Recreation Committee. If others would like to join our small team, please call Jolene at City Hall so she can connect us together. Effective October 1, 2022, I will be retiring from this volunteer role and hope to have the new team trained and productive well before that date.
- And lastly, just a view of what is possible when good people join forces:
  - \$645,515 amount of \$ we have requested from grant providers since Oct. 2017
  - \$331,695 amount we have been awarded, so far, and more on the way.....

## **MESSAGE FROM THE CLERK'S OFFICE**

The City's General Election will be held on Tuesday, November 8th this year, with a possible August Primary held on Tuesday, August 2th. We will be



electing a Mayor for a (2) two-year term and three (3) Council seats (four-year terms). The deadline to turn in nominating petitions for Mayor and Council is April 19th by 4:00 p.m. Anyone interested in running for an elected office can pick-up their nominating petition at City Hall.

If you are asked to sign a nominating petition, please list all the information requested on the form. You may sign one petition for Mayor and three petitions for Council. If you sign more than this, only your first signatures respective to these positions will be counted. If you have not yet registered for the August Primary or the November General election, the deadline for the August Primary is July 18, 2022. The last day to register for the November General Election is October 24, 2022. This can be done at City Hall during regular business hours or at any Michigan Secretary of State Branch office.

If you need an Absent Voter Ballot Application, please stop at City Hall during regular business hours or call 734- 848-6495 ext. 205. I can mail an Absent Voter Ballot Application to you. The



polls will be open from 7 a.m. until 8 p.m. on Election Day at the Luna Pier Fire Hall.

With the passing of Proposal 18-3 in November 2018 all eligible and registered voters in Michigan may now request an absent voter ballot without providing a reason. Simply call the City before an election and request one and it will be sent to you. Also if anyone would like.to be added to the city's permanent absentee voter list please me and you will receive an absentee voter application automatically for every election. When a registered voter comes to the polls please bring a photo ID. Here are the acceptable forms of identification:

- Michigan driver's license or state-issued ID card
- Driver's license or personal identification card issued by another state

- Federal or state government-issued photo identification
- U.S. passport
- Military ID with photo
- Student identification with photo from higher school or accredited institution or higher learning
- Tribal identification card with photo

I hope to see everyone at the polls in 2022 and exercise your right to vote. If anyone is interested in becoming an Election Inspector please give me a call.
